# **General information**

## Advice on protection against fire and explosion

Isolate from sources of heat, sparks and open flame. No sparking tools should be used. Electrical equipment should be protected to the appropriate standard. Mixture may charge electrostatically: always use earthing leads when transferring from one container to another. Vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air.

In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits. Sufficient protection is given wearing suitable protective gloves checked according to i.e. EN 374, in the event of risk of skin contact with the product.
