4.1 Description of first aid measures

General information

7.1 Precautions for safe handling

Advice on safe handling

Due to the organic solvents' content of the mixture: Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentration higher than the occupational exposure limits.
